How to link Aadhaar card to Bussan Auto Finance India (BAF India) Loan Account

Govt. of India has mandated to update Aadhaar Number and PAN card details with Loan accounts by 31-MAR-18. If Loan account holder has not applied & don't have PAN card then he / she is required to submit Form 60 as declaration of same. Accordingly, BAF India introduced following 3 modes by which it's Loan account holders can submit related details and documents to update records and authorise BAF India to authenticate the same with appropriate authority.
